

**ARTICLES OF INCORPORATION**

OF

**PICCOLA ITALIA PACKAGING COMPANY**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

**ARTICLE I. NAME**

The name of the Corporation shall be:

**PICCOLA ITALIA PACKAGING COMPANY**

The principal place of business of this Corporation shall be:

**37502 County Rd. 54 W., Zephyrhills, Florida 33541.**

**ARTICLE II. NATURE OF BUSINESS**

This Corporation may engage in, or transact, any or all lawful activities or business permitted under the Laws of the United States, the State of Florida, or any other State, Country, Territory or Nation. The specific purpose of this Corporation shall be to package and sell restaurant products, and related services.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 500 shares of common stock having a par value of \$1.00 per share.

**ARTICLE IV. ADDRESS**

It is the intent of the incorporators that the Corporation will file as a Sub-Chapter S Corporation.




