ARTICLES OF INCORPORATION OF ANNWIL INTERNATIONAL, INC.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. <u>Name</u>

The name of the Corporation is: Annwil International, Inc.

II. Term of Existence

The date when corporate existence will commence is March 26, 2009 in accordance with Section 607.0203(1) of the Act.

III. Principal Office

The principal office and mailing address of the Corporation is 5204 St. Paul Street, Tampa, Florida 33619.

IV. Capital Stock

The Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which will be designated Common Stock.

V. Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 501 East Kennedy Boulevard, Suite 1700, Tampa, Florida 33602, and the name of its initial registered agent at such address is Andrew L. McIntosh, Esquire.

VI. Directors

The Corporation will have 3 directors initially. X. <u>Bylaws</u>

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.
