ARTICLES OF INCORPORATION

OF

SOJOURN HOUSE RECOVERY RESIDENCES, INC.

The undersigned incorporator and subscriber, being a natural person competent to contract, in compliance with Chapter 607, F.S., hereby organizes and incorporates under the laws of the State of Florida a corporation for profit as follows:

ARTICLE I - Name of Corporation

The name of this corporation shall be SOJOURN HOUSE RECOVERY RESIDENCES, INC. (the "Corporation").

ARTICLE II - Registered Office and Agent

The street address of the initial registered office of this Corporation in the State of Florida is 515 North Flagler Drive, 7th Floor, West Palm Beach, Florida 33401, and the name of the initial registered agent of this Corporation at that address is Gregory S. Kino.

Having been named as registered agent to accept service of process for the above stated Corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.

ARTICLE III - Nature of Business

This Corporation is organized for the purpose of transacting any and all lawful business which corporations may transact pursuant to Chapter 607, Florida Statutes.

ARTICLE IV - Capital Stock

Property, labor or services may be purchased or paid for with the capital stock at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.
