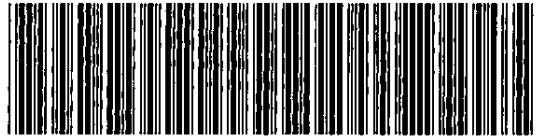

ARTICLES OF INCORPORATION
OF
ELEGANT IMAGERY, INC.

SECRETARY OF STATE

The undersigned, pursuant to Chapters 607 and 621 of the Florida Statutes, state as follows:

ARTICLE I

NAME

The name of the corporation is Elegant Imagery, Inc.

ARTICLE II

PURPOSE

The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business allowed by the Florida Statutes, specifically providing photography services throughout the State of Florida.

ARTICLE III

SHARES

2. Celeste Buus, a resident of the State of Florida, at the address of 1745 La Maderia Dr. SW, Palm Bay, Florida 32908.

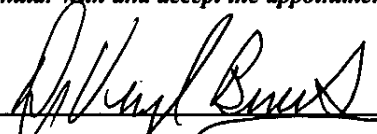
ARTICLE VIII

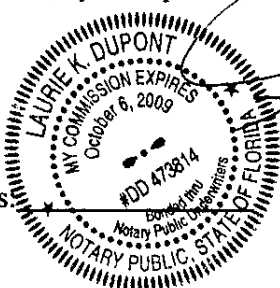
