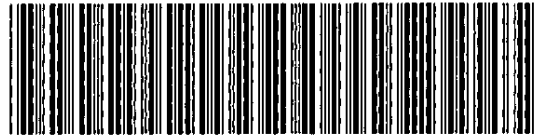

ARTICLES OF INCORPORATION

OF

J & M Express Auto Carrier Inc

ARTICLE I

Name and Duration

The name of the J & M Express Auto Carrier Inc The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 1450 NE 151 Ter. N. Miami Beach, FL 33162

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 1450 NE 151 Ter N. Miami Beach, FL 33162. The name of the registered agent at such address is Moudy Blanchet

ARTICLE IV

Corporate Purposes, Powers and Rights

1. The nature of the business is TRUCKING and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

The Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by statute, and all rights conferred upon shareholders herein are granted subject to this reservation.

ARTICLE VIII

Bylaws

The power to adopt, amend or repeal bylaws for the management of this Corporation shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the Board of Directors.

The Corporation shall indemnify any incorporator, officer or director, or any former incorporator, officer or director, to the full extent permitted by law.
