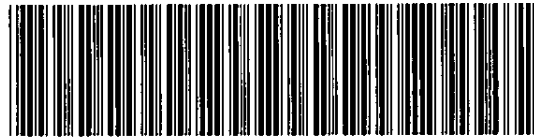

ARTICLES OF INCORPORATION
OF
BUGGY AUTOMOTORES CORPORATION

The undersigned incorporator to these Articles of Incorporation, a natural person over the age of 18 years, competent to contract and a citizen of the United States of America, hereby forms a corporation in accordance with the provisions of chapter 607, Florida Statutes.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be: BUGGY AUTOMOTORES CORPORATION.

ARTICLE II

PRINCIPAL OFFICE

The initial principal place of business and mailing address of the corporation shall be: 2588 Ulysses Road, Tallahassee, Leon County, Florida 33432.

ARTICLE III

NATURE OF BUSINESS

The purpose of the corporation is to engage in any and all lawful business for which corporations may be incorporated under applicable Florida law.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares that this corporation is authorized to issue is 100 shares of common stock having a par value of \$1 per share. The common shares shall have unlimited voting rights, with each share being entitled to one vote, and the right to receive the net assets of the corporation upon dissolution, with each share participating on a pro rata basis.

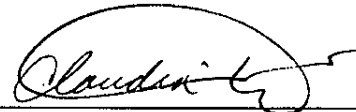
