The undersigned, acting as Incorporator of Weingarten Holding, Inc. (the ACorporation@) under the Florida Business Corporation Act (Chapter 607) of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I
NAME**

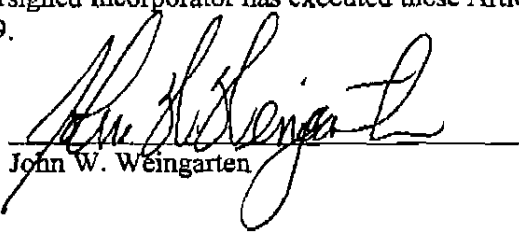
