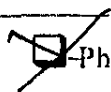

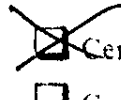

The undersigned, for the purpose of forming a corporation under the provisions of The Florida Business Corporation Act and Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name shall be: **OJATRO HOME IMPROVEMENTS, INC.**

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

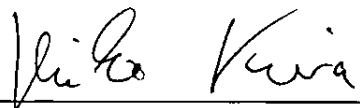
