Enclosed are three manually signed originals of Articles of Incorporation, accompanied by a check in the amount of \$52.50 payable to the Florida Secretary of State for the filing fees and receipt of two certified copies.

With regard to the group's organization process, please note that in the latter part of 2008 and the first part of 2009, the group undertook discussions and efforts with the FDIC seeking to amend its application through a reduction in its initial capitalization coupled with the elimination of a banking office. In essence, the group's efforts sought to reduce the expansion plans of the Bank and, at the same time, also request permission for a reduced capital amount in recognition in that adjustment in growth as well as the prevailing investment and economic environment. Ultimately, while a number of discussions were held, the FDIC indicated that it was not in a position to approve an amendment to the charter application to reduce the initial capital amount.

As a part of all these discussions, it did not appear practical, and would in fact have been misleading, to place Articles of Incorporation in the public file which would memorialize a capital structure that was under discussions for a negotiated adjustment to the capital amounts. While the approval letter from both the Florida Office and the FDIC had set forth a certain capital amount which would have been memorialized in Articles of Incorporation, the possible renegotiated numbers

# ARTICLES OF INCORPORATION OF 1st PERFORMANCE BUSINESS BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be 1<sup>st</sup> Performance Business Bank and its initial place of business shall be located at 186 North Palafox Street, Pensacola, Florida 32502.

#### ARTICLE II

The general nature of the business to be transacted by this corporation shall be that of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

#### ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 3,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share. The corporation shall begin business with at least \$7,875,000 in paid-in common capital stock to be divided into 1,575,000 shares. The amount of surplus with which the corporation will begin business will be not less than \$7,125,000.

#### ARTICLE IV

The term for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

#### ARTICLE V
