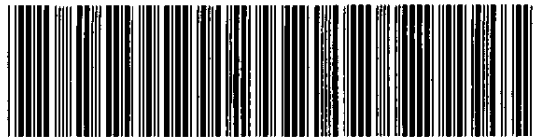



The name of the corporation is, TRANSIT DYNAMICS, INC.

II. TERM OF EXISTENCE




