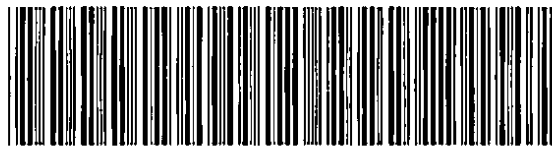

The dissolution was authorized on September 15, 2023.

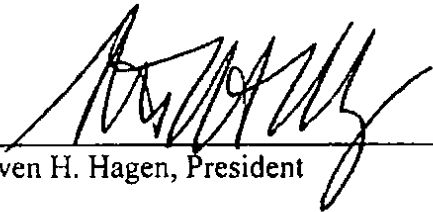
ARTICLE IV
