**RESTATED ARTICLES OF INCORPORATION  
OF  
SUMMIT BROADBAND INC.**

(Pursuant to Section 607.1007 of the  
Florida Business Corporation Act)

**ARTICLE 1  
NAME**

The name of the corporation is Summit Broadband Inc. (the "Corporation").

**ARTICLE 2  
PRINCIPAL OFFICE**

The street address of the initial principal office and mailing address of the Corporation is 4558 35<sup>th</sup> Street, Suite 100, Orlando, Florida 32811.

**ARTICLE 3  
SPECIFIC PURPOSE**

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

**ARTICLE 4  
AUTHORIZED SHARES**

The Corporation shall have authority, to be exercised by the Board of Directors, to issue no more than one thousand (1,000) shares of capital stock. These shares shall be one class, \$0.01 par value per share, and shall be designated as "Common Stock." The holders of Common Stock shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution.

**ARTICLE 5  
REGISTERED OFFICE AND AGENT**

The street address of the registered office of the Corporation is 4558 35<sup>th</sup> Street, Orlando, Florida 32811, and the name of the registered agent of the Corporation at the registered office is Brenda Kincaid.


**ARTICLE 6
