SVMFL GROUP, INC.

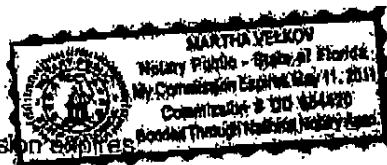
