**FIRST:** The name of the Corporation is CLEO TRADING, INC. and the date of its incorporation is April 10, 2009.

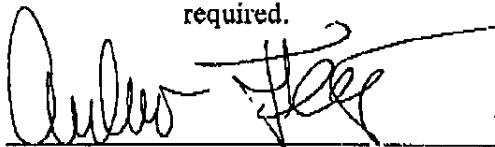
**SECOND:** Article IV entitled, "Board of Directors" is amended to read:
