#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of this Corporation is VGK Pools, Inc.

#### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

#### ARTICLE III - BUSINESS AND PURPOSE

This Corporation is organized for the following purposes:
