To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property or any interest therein, wherever situated;

To sell, convey, mortgage, pledge, create a security interest in lease exchange, transfer, and otherwise dispose of all or any part of its property and assets. To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute Section 607.141;
