Pursuant to the provisions of section 607.164 of the Florida Statutes, the undersigned incorporator adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be CHARLES R. DREW FOUNDATION, INC., and the principal place of business shall be 7946 NW 162 St. Miami Lakes, Fla. 33016

ARTICLE II

This corporation shall have perpetual existence connecting upon the date of the filing of these Articles of Incorporation.

ARTICLE III

This corporation is organized for the purpose of transacting any and all lawful business in the Florida and the United States of America. The purpose of the corporation shall be to promote blood donations and marrow donations within the community

ARTICLE IV

This corporation shall be authorized to issue 100 shares of common stock, having a par value of \$1.00.

ARTICLE V

Except as otherwise provided by law, the entire voting power for election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common stock of said corporation.

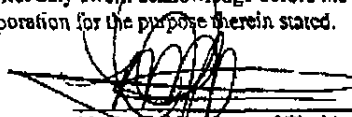
