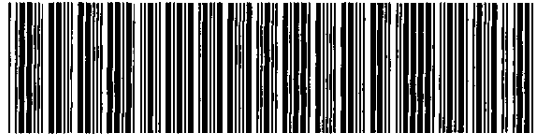

Article I - Name

The name of this corporation is TOBIN J. REED LAWN SERVICE, INC...

Article II - Duration

This corporation shall exist perpetually commencing on April 15, 2009.

Article III - Purpose

This corporation is organized:

The directors of this corporation may take action by written consent, as provided by law.


Article XI - Indemnification


