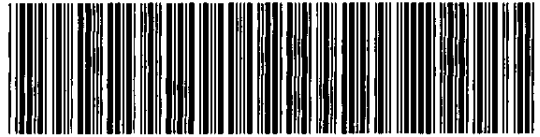

(name)

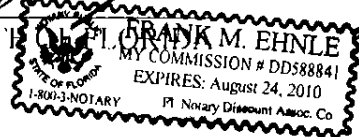
