The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

# ARTICLE I

# NAME AND ADDRESS

- Section 1.1 Name. The name of the corporation is Cooper Amelia Company (the "Corporation").
- Section 1.2 <u>Address of Principal Office</u>. The address of the principal office of the Corporation is 25 West Prospect Avenue, Suite 1400, Cleveland, Ohio 44115-1048.
