ARTICLE I. NAME

NAME: The name of this corporation shall be: WWD CONTRACTING, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business of this corporation is located at 4324 Griffin View Drive, Lady Lake, Florida 32159. The mailing address of the corporation is 4324 Griffin View Drive, Lady Lake, Florida 32159.

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is to engage in the business of general contracting and other related business activities, as permitted under the laws of the United States and the State of Florida.

ARTICLE IV. SHARES

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.
