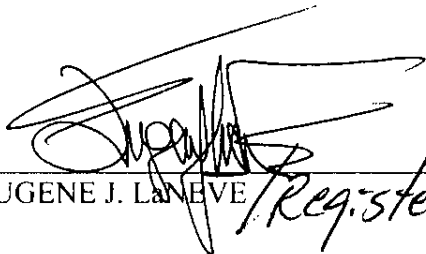
ARTICLE VIII - INDEMNIFICATION
