ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this Corporation is KARIM MORALES, DMD, P.A.

ARTICLE II. DURATION

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE

The general nature and purposes of business to be transacted, promoted, and carried on by the Corporation are as follows:

- a. To engage in every aspect in the practice of dentistry and all its fields of specializations, as are engaged in by licensed dentist.
- b. To engage and render the professional serviced involved only through its officers, agents and employees who shall be dentist in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this Corporation.

Any action of the Shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the Shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the Corporation as part of the corporate records.

ARTICLE XI. INFORMAL DIRECTOR ACTION

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the Corporation, and the writings evidencing their consent are filed with the Secretary of the Corporation, the action shall be valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XII. SEVERANCE AND TERMINATION OF EMPLOYMENT


