
Dear Mr. Shivers:

## ARTICLES OF INCORPORATION OF ROBERTA TENTERDY, P.A.

The undersigned incorporator, who is a licensed real estate broker/salesperson in the State of Florida, forms a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopts the following Articles of Incorporation for the corporation.

### ARTICLE 1 - NAME/ADDRESS

The name of this corporation is **ROBERTA TENTERDY, P.A.**, and its mailing and principal office address is 8 South Washington, Sarasota, Florida 34236.

### ARTICLE 2 - PURPOSE




