ARTICLE I - NAME

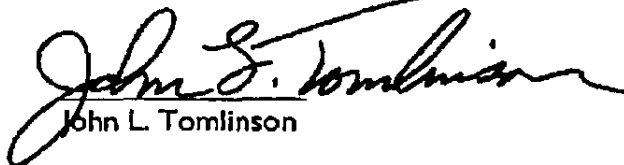

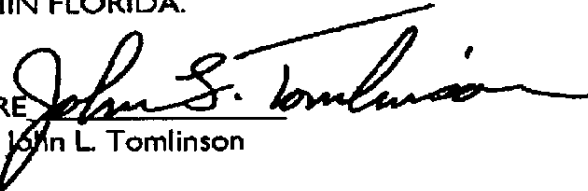

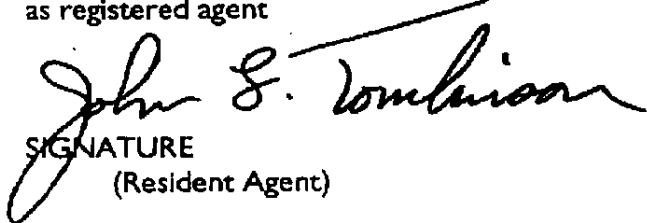
