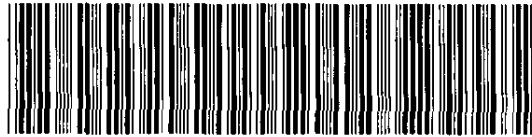

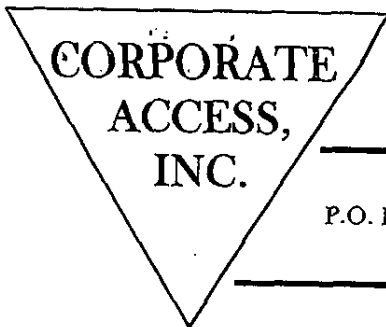

ARTICLE X – GENERAL

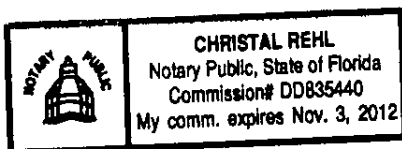
- A. Unless otherwise stated in the By-laws, every stockholder who has the right to vote shall have the right to vote in person or by proxy.


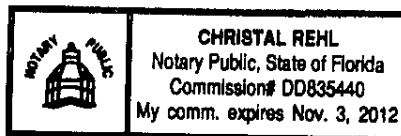
