**ARTICLE I. CORPORATE NAME.**

The name of this corporation is: Wireless Mobile Communications & Entertainment Systems, Corp., a Florida corporation.

Corporate Address: 240 East Flagler Street, Miami, Florida 33131

**ARTICLE II. NATURE OF BUSINESS.**

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

**ARTICLE III. DURATION.**

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: April 24, 2009.

**ARTICLE IV. CAPITAL STOCK.**

- G. Dividends:** Record holders of Common Stock are entitled to receive their pro-rata share of any dividends that may be declared by the Board of Directors out of assets legally available for such purpose.
- H. Liquidation Rights:** Holders of Common Stock are entitled, in the event of liquidation or dissolution of this corporation, to receive their pro-rata share of any assets of this corporation remaining after payment of all corporate debts and obligations.

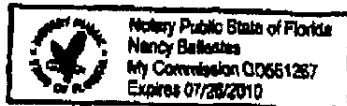
