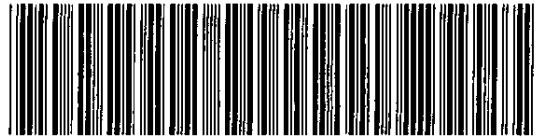

1. **Name.**

The name of the Corporation is Diesel 2 Gas, Inc.

2. **Initial Principal Office and Registered Agent.**

Its registered office in the State of Florida is 320 E. Kennedy Blvd., Suite 200, in the City of Tampa, County of Hillsborough. The name of its registered agent at such address is **Elio E Muller Jr.**

3. **Purposes.**

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida.

4. **Capital Stock.**
