
#### INDEMNIFICATION

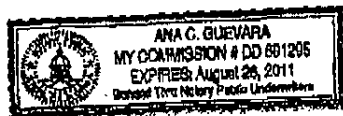


