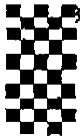

**ARTICLES OF INCORPORATION OF
ROYAL PALM DENTISTRY, P.A.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article 1.
Name and Address**

The name of the Corporation is Royal Palm Dentistry, P.A. The principal office, if known, or the mailing address of the Corporation is 989 North Collier Boulevard, Marco Island, Florida 34145.

**Article 2.
Duration**

The duration of the Corporation is perpetual.

**Article 3.
Purpose**

To practice Dentistry.

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.
