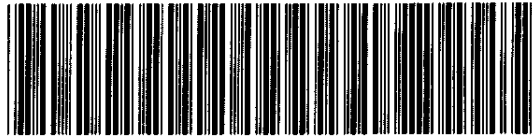

ARTICLES OF INCORPORATION OF SOVEREIGNTY ACTION, INC.

(F.S. 607, a closed small subchapter S corporation, for profit)

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

NAME: The name of the corporation is Sovereignty Action, Inc..

TERM: The duration of the corporation is perpetual.

PURPOSE: To transact any lawful business.

INITIAL SHARES: issue 10 shares of stock having a par value of \$1.00 per share.

REGISTERED OFFICE AND AGENT: The address of the registered office of the corporation is 3550 S.E. 25th Av., Ocala, Fl. 34471, and the name of its initial registered agent there is Phil Trovillo

MANAGEMENT: The corporation shall be managed by its shareholders, as a closed corporation, or designated business functions may be managed by the Chairman of the Board of Directors or the President. The corporation may also elect a Board of Directors, which may also have management functions, or which may manage all of the business affairs of the corporation upon there being an appropriate resolution. The Executive Committee made up of the Officers, may act for the Board when it is untimely or inconvenient to call a Board meeting. The Board of Directors shall have 1-5 directors, and the names and addresses of the first Board of Directors are: Phil Trovillo. The number of Directors may be changed at any time by a Resolution passed by two thirds of the Shareholders at any regular or special meeting after legal notice of the meeting to each registered holder of stock.

INCORPORATORS: The name and address of each incorporator is: Phil Trovillo, 3550 S.E. 25th Av., Ocala, Fl. 34471.

CAPITAL STRUCTURE-SUBCHAPTER S CORPORATION: The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 10 persons. Stock shall be issued and transferable only to natural persons who are not non-resident aliens.

OFFICERS: The names and addresses of the initial officers of this corporation are : President, Vice President, - Phil Trovillo, 3550 S.E. 25th Av., Ocala, Fl. 34471.

OFFICE: The principal office of the corporation and its address is that of the President: 3550 S.E. 25th Av., Ocala, Fl. 34471.

AMENDMENTS: These Articles may be amended in any manner as provided by law. Every amendment shall be approved by a majority of the stockholders then entitled to vote.

BEGINNING OF CORPORATE EXISTENCE: When approved by the Florida Department of State.
