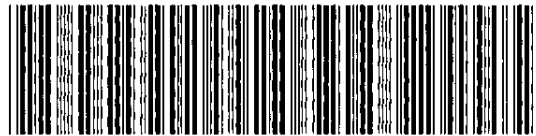

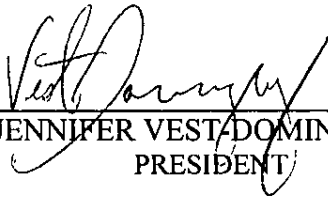
XIII

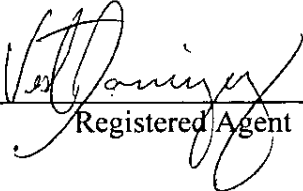
