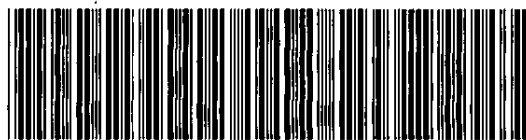

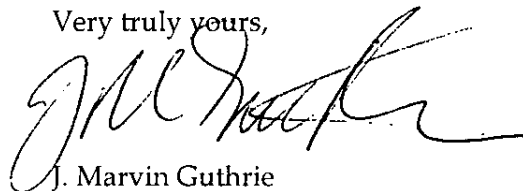

**ARTICLES OF INCORPORATION
OF

**Article I.
Name.**

The name of this corporation shall be HOME PRO CONSTRUCTION, INC., and the initial principal office and mailing address of the corporation shall be 2092 59TH Way North, Clearwater, FL 33760.

**Article II.
Purpose**

This corporation is organized to engage in any activity of business permitted under the laws of the United States or of this State.

**Article III.
Term of Existence**

This corporation shall begin existence as of the date of filing and shall exist perpetually.

**Article IV.
Capital Stock**

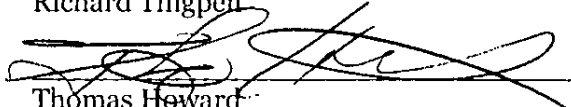
