**ARTICLES OF INCORPORATION
OF
GVI HOLDINGS, INC.**

(a Florida corporation)

THE UNDERSIGNED, acting as sole incorporator of **GVI HOLDINGS, INC.** (the "Corporation"), under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

Name

The name of the Corporation is **GVI HOLDINGS, INC.**

ARTICLE II

Principal Office
