To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses in the State of Florida, and in all other states, districts, territories, countries or colonies. To purchase the corporate assets of any other corporation and engage in the

To acquire by purchase, subscription or otherwise, and to receive, hold, own,

guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or

otherwise dispose of or deal in and with any of the shares of the capital stock, or any

voting trust certificates in respect of the shares of capital stock, scripts, warrants,

rights, bonds, debentures, notes, trust receipts, and other securities, obligations,

chosen in action and evidence of indebtedness or interest issued or created by any

corporation, joint stock companies, syndicates, associations, firms, trust, or persons,

municipality or other political subdivision or by any governmental agency, and as

In general, to carry on any other business in connection with the foregoing, and to

have and exercise all the powers conferred by the laws of Florida upon

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 1000 shares of common stock with a par value of \$1.00.

All the aforementioned stock is to be issued as fully paid for and exempt from assessment.

The capital stock is being issued pursuant to section 1244 of the Internal Revenue Code, the pertinent provisions of which are hereby incorporated herein by reference and made a part hereof.

#### ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

# ARTICLE V. INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

The Board of Directors, may from time to time, move the registered office to any other address in Florida.

#### ARTICLES VI. DIRECTORS

This corporation shall have two director(s) initially. The number of directors

may be increased or decreased from, time to time in such a manner as may be prescribed by the By-Laws, but shall never be less than two (2).

at any time hereafter as a director or officer of the corporation, and any person who serves at the request of this corporation, from and against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director or officer of the corporation, or by reason of any action alleged to have been heretofore or hereafter taken or omitted by him as such director or officer, and shall reimburse each person for all legal and other expenses reasonably incurred by him in connection with any such claim or liability provided that no person shall be indemnified against, or be reimbursed for, any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or willful misconduct in the performance of his duties.

The rights occurring to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled, nor shall anything herein contained restrict the right of the corporation to indemnify or reimburse such person in any proper cause even though not specifically herein provided for.

No contract of other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be effected or invalidated by the fact that any of the directors of the corporation pecuniary or otherwise


