

ARTICLES OF INCORPORATION OF CASOLSA . Inc.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

Article I Name

The name of the corporation is:

Article II Duration

This corporation shall exist perpetually. Article III Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV Capital Stock
