

ARTICLE I

NAME. The name of the corporation shall be **VIERA'S LINKS TRUCKING, INC.**

ARTICLE II

PRINCIPAL OFFICE. The principal place of business and mailing address of this corporation shall be 13947 Southwest 44th St., Lane Circle, Unit #C, Miami, Florida 33175.

ARTICLE III

DURATION. The corporation shall have perpetual existence unless dissolved according to law and its existence shall commence on the date of execution and acknowledgment of these Articles of Incorporation.




