

## ARTICLES OF INCORPORATION OF KIRKPLAN CONSTRUCTION, INC



#### ARTICLE I

Name. The name of this corporation is KIRKPLAN CONSTRUCTION, INC.

#### ARTICLE II

Duration. The corporation shall be perpetual.

#### ARTICLE III
