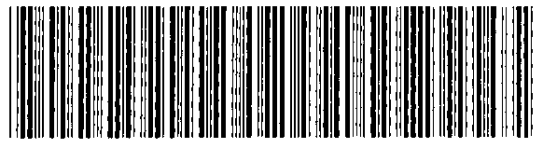

The name of this Corporation is Accendo Capital Group, Inc. and its address is 1500 Miami Center (RJS) 201 South Biscayne Boulevard, Miami, Florida 33131.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


ARTICLE IX – INCORPORATOR
