ARTICLES OF INCORPORATION OF PMC Drafting, Inc

The undersigned incorporator hereby makes, subscribes to, acknowledges and free these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be **PMC Drafting**, **Inc** and it shall be hereinafter referred to as the "corporation".

ARTICLE II

The general purposes for which the corporation is initially organized are as follows:

- a. Any business activity authorized by the laws of the State of Florida.
- b. To transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes (1979) as amended.

ARTICLE III
