ARTICLES OF INCORPORATION

OF

KIM GROUP HOME, INC.

The undersigned, acting as incorporator of KIM GROUP HOME, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is KIM GROUP HOME, INC.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE
