The U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) administers and enforces an economic sanctions program targeting individuals and entities contributing to the situation in Venezuela, as set forth in the Venezuela Sanctions Regulations, 31 C.F.R. part 591 (VSR) and Executive Orders, issued under the authority of the International Emergency Economic Powers Act, 50 U.S.C. §§ 1701-06 (IEEPA), and other statutes. The VSR generally prohibit all transactions by U.S. persons or within the United States involving the property or interests in property of any individual or entity blocked pursuant to this sanctions program unless authorized by OFAC or exempt.

The Florida Division of Corporations is hereby notified that on May 18, 2018 (the "Designation Date"), OFAC designated the following individual and entities as Specially Designated Nationals and Blocked Persons ("SDNs") pursuant to Executive Order 13692, "Blocking Property and Suspending Entry of Certain Persons Contributing to the Situation in Venezuela," which is implemented by the VSR and the Reporting, Procedures and Penalties Regulations, 31 C.F.R. part 501 (collectively, the "Regulations"):

2. Jose David Cabello Rondon ("J. Cabello")
3. Marleny Josefina Contreras Hernandez ("Contreras")

**As a result of OFAC's designation, SAI, NPI, and 11420 Corp. are blocked, and any of their property or interests in property are also blocked. Blocked property may not be transferred, sold, or otherwise dealt in without authorization from OFAC.**

More broadly, any and all property and interests in property of Mr. D. Cabello, Mr. J. Cabello, Ms. Contreras, Mr. Sarria, SAI, NPI, 11420 Corp., or other designated or blocked persons have an interest that are within the United States or within the possession or control of U.S. persons,<sup>1</sup> including their foreign branches, are, with limited exceptions, blocked and may not be transferred, paid, exported, withdrawn, or otherwise dealt in. Any transaction or dealing by a U.S. person, or within the United States, in any property or interests in property of Mr. D. Cabello, Mr. J. Cabello, Ms. Contreras, Mr. Sarria, SAI, NPI, 11420 Corp., or other designated or blocked persons is prohibited unless authorized by OFAC or exempt, as is any transaction or dealing that evades or avoids this prohibition.

OFAC will consider requests for specific licenses to ameliorate the effects of this blocking action. <sup>1</sup> A "United States person" or "U.S. person" means any United States citizen or national, permanent resident alien, entity organized under the laws of the United States (including foreign branches), or any person in the United States. 31 C.F.R. § 591.312.

Unauthorized transactions in property blocked under the Regulations may result in a civil monetary penalty of up to the greater of \$295,141 or twice the value of the transaction for each underlying transaction. IEEPA also provides for criminal penalties for any person who willfully commits, willfully attempts to commit, or willfully conspires to commit, or aids or abets in the commission of, an unlawful act. Criminal penalties include up to 20 years in prison, fines up to \$1 million, or both.
