

ARTICLES OF INCORPORATION

ARTICLE I – NAME

The Name of this corporation is: TON-TEA TRADING CORPORATION.

ARTICLE II – DURATION

This corporation shall have perpetual existence commencing on the date of this the filing of these articles with the Department Of State.




