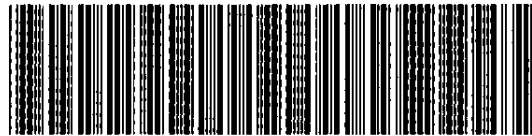



The undersigned Bryan G. Kuhn, does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be BRADLEY LOCK AND KEY, INC..

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted is service and sales.
