

Re: Viktor Laza v. Jing Hayes and Leak Squad Services of SW FL, Inc.

Dear Ms. Cosby and Mr. Hayes,

Please find attached a Complaint for Federal and Common Law Trademark Infringement. On numerous occasions, we have attempted to reach an amicable resolution to this issue, but you have continuously refused our very reasonable overtures. As such, we have drafted the attached Complaint that we intend to file against you based upon your willful trademark infringement. Even though we have drafted this Complaint, we have not filed it with the United States District Court for the Middle District of Florida.

Instead, my client has elected to attempt, one last time, to resolve this matter short of litigation. If you fail to adhere to the demands herein in an effort to reach an amicable resolution, my client will be left with no choice but to file the attached Complaint. Once the Complaint is filed, my client will vigorously defend its trademark rights and seek substantial monetary damages from you for your wrongful and willful activities, including all gains, profits, and advancements derived from your services and the recoupment of his attorneys' fees and costs.

You were repeatedly notified of our client's registered federal trademarks for LEAK SQUAD and THE LEAK SQUAD since May 30, 2019. You have refused to discontinue your use of a confusingly similar mark, which we believe results in a clear case of willful trademark infringement. As such, we again demand that you:

- (1) immediately and permanently cease using the Leak Squad name and any other

confusingly similar name, now or in the future;

(2) immediately cease your advertising campaign that includes the Leak Squad name and any other confusingly similar name, and notify any advertising avenues to immediately cease from using any ads with the Leak Squad name;

(3) immediately and permanently cease publishing, ordering, displaying, using, placing and distributing statements, products, social media, forms, websites, web pages, website code, forms, metatags, metadata, adWords, keywords, and any other advertising, marketing, and promotional materials (including on the Internet or via print media, social media, television, or radio) making use of the Leak Squad name, or any other name that is confusingly similar to our client's marks, now or in the future;

(4) within twenty (20) days from the date of this letter, you provide the undersigned with a written assurance that you have complied and will comply with paragraphs (1) through (3) above.

If we fail to hear from you within 20 days, we will file and serve the enclosed Complaint against you.

Nothing contained herein shall be deemed a waiver of any of our client's rights and remedies, all of which are specifically reserved.
