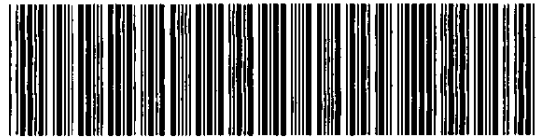

Change of name from **Tomoka Physical Therapy, Inc.** to **Tomoka Therapy, Inc.**


