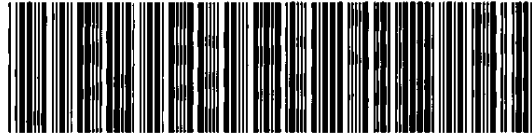

**ARTICLES OF INCORPORATION OF

ARTICLE I

The name of the corporation is FEHR CORPORATION, having its principal office located at: 18630 Royal Hammock Boulevard, Naples, Florida 34114.

ARTICLE IV

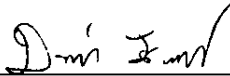
There shall be no preemptive rights accruing to the shareholders.

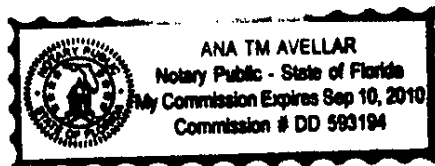
