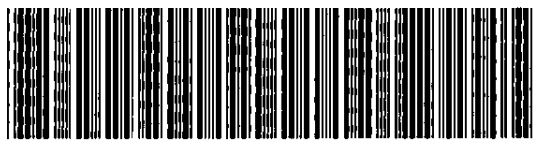

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The Name of this corporation is TENDENZA USA. INC.

ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement corporation existence is upon the date of execution of this articles of incorporation.

ARTICLE THREE

The general purpose for which this corporation is organized:

1. To engage in any activity or business permitted under the laws of the United States and of the State of Florida, including the import and export of tiles.
