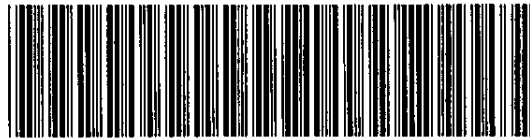

The following Plan of Merger is submitted in compliance with Section 607.1101, Florida Statutes, and is in accordance with the laws of the State of Florida.

1. Pluris Wedgefield, Inc. shall merge into Pluris PCU, Inc. and Pluris PCU, Inc. shall be the surviving corporation.

2. The merger shall become effective upon approval of the shareholders of each corporation and the filing of Articles of Merger with the Florida Department of State.

3. Each share of Pluris Wedgefield, Inc. shall be converted into a share Pluris PCU, Inc.

4. Simultaneous with the merger, an Amendment to the Articles of Incorporation of Pluris PCU, Inc. shall be filed changing its name to Pluris Wedgefield, Inc.
