
INDEMNIFICATION

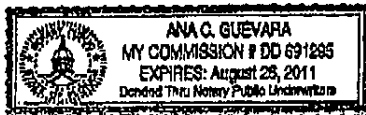




